### YOUR ADOR MEMBERSHIP IS TAX DEDUCTIBLE IN FRANCE, THE EU AND THE USA

ADOR is a non-profit organization eligible to receive tax-deductible charitable contributions, governed by the law of July 1, 1901, registered at the Prefecture of Yvelines.

**FOR INDIVIDUALS TAXABLE IN FRANCE:** Your Donation is eligible for tax deductions up to 66%. A tax receipt will be provided for all donations.

**FOR INDIVIDUALS TAXABLE IN EUROPE:** The Transnational Giving Europe network (TGE) allows you to join ADOR and benefit directly from the tax benefits provided by the legislation of your country of residence. A tax receipt will be provided for all donations.

#### FOR AMERICAN TAX RESIDENTS

Donors taxable in the United States can benefit from a tax reduction provided by the Internal Revenue Service (IRS) through our partner, the French American Cultural Foundation.

**SUBJECT TO REAL ESTATE WEALTH TAX (IFI)?:** Donors taxable in France for real estate wealth tax (IFI) can benefit from a tax reduction of 75% of the donation amount, within an annual limit of €50,000. The Foundation of the Royal Opera is eligible for this scheme.
